1 MILE. (1:33) STAKES. Purse \$500,000 Gulfstream Park H.FOUR YEAR OLDS AND UPWARD. Free nomination by Sunday, February 21. \$5,000 to enter and \$2,500 to start, with all starters to receive a \$2,500 rebate in addition to the purse. \$500,000 Guaranteed. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weights: Saturday, February 27. Starters to be named through the entry box by the usual time of closing. Supplemental nominations may be made at time of entry, with weight to be assigned at that time. All fees shall be paid prior to the start of the race. This race will be limited to 14 starters, with also eligibles. If more than 14 entries pass the entry box, preference will be given to highweights, then highest career earnings. Trophy to the winning owner. (Cloudy 75)

BLOFELD tracked the pace of STANFORD from the inside, followed that stable-mate out into the stretch, angled in nearing the furlong marker, responded to steady urging and was up in the closing yards. STANFORD pressed the pace of ANCHOR DOWN from the inside, moved up to engage that foe nearing the quarter, drifted out slightly into the lane, opened a clear lead with a furlong to run, responded when challenged by the winner late and just missed in a game effort. ANCHOR DOWN set a pressured pace while racing three-wide, responded when challenged by STANFORD nearing the quarter, drifted out in mid-stretch bumping with VALID, was straightened away and finished willingly. VALID stalked the leaders while racing three-wide, moved up for a striking position in mid-stretch, was bumped by ANCHOR DOWN, clipped that rivals heels, stumbling and almost unseating his rider and lost best chance. ITSAKNOCKOUT settled off the leaders early, moved three-wide though the turn, angled out approaching the stretch and failed to gain in the drive. HESINFRONT lagged early, saved ground through the turn and did not reach contention. GRANDE SHORES lacked early foot, raced three-wide through the turn and was not a factor. THE STEWARDS CONDUCTED AN INQUIRY CONCERNING THE BUMPING INCIDENT AND CLIPPING HEELS IN MID-STRETCH BETWEEN VALID AND ANCHOR DOWN AND AFTER REVIEWING THE FILMS CONCLUDED ANCHOR DOWN WAS AT FAULT COMING OUT AND BUMPING VALID AND WAS DISQUALIFIED FROM THIRD AND PLACED FOURTH.
