

**ELEVENTH RACE**  
**Gulfstream Park**  
**March 31st, 2018**

1 MILE. (Turf) (1:31 $\frac{1}{2}$ ) STAKES. Purse \$250,000 Honey Fox S. (Grade III) FILLIES AND MARES, FOUR YEARS OLD AND UPWARD. Free nomination by Sunday, March 18. \$2,500 to enter. \$250,000 Guaranteed. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. Weight: 123 lbs. Non-winners of a graded stakes on turf since October 1 allowed 2 lbs.; a stakes race on turf since October 1, 4 lbs.; three races other than maiden, claiming, or starter, 6 lbs. Starters to be named through the entry box by the usual time of closing. Supplemental nominations may be made at time of entry. All fees shall be paid prior to the start of the race. This race will be limited to 14 starters, with also eligibles. If more than 14 horses are entered, preference will be given to graded stakes winners, then by highest career earnings. In the event this race is taken off the turf, it may be subject to downgrading upon review by the Graded Stakes Committee. (If deemed inadvisable to run this race over the turf course, it will be run on the main track at One Mile). (Clear 78)

Bay Filly, (Apr), by War Front - Quiet Now by Tiznow. Trainer Christophe Clement. Bred by Claiborne Farm & Adele B. Dilschneider (KY).

LULL led the way securing inside position in first turn, continued clear and comfortable carving sharp fractions on top, smartly saved ground still unleashed at the quarter pole, shook reins entering top stretch, responded willingly, widening advantage on top, drifted in when tapped right handed at eighth pole, margin on top began to shorten in final furlong, urged left handed, came out few paths, remained determined and just lapped on wire, sharp performance. RES IPSA was unhurried heading into first turn then remained reserved in back with fast pace being set on top, saved ground near the inside then angled out losing some ground entering far turn, given cur racing wide top stretch, responded gamely, rallied strongly racing widest got denied by nose on wire. ON LEAVE was firmly rated under snug hold with quick pace being set on top, ranged up closer midway through far turn then sent wide entering lane, responded when put to drive and produced solid finish. ISLAND REWARD raced off early pace, hit some traffic entering top stretch then made way through two path then dropped inside improving position. STORMY VICTORIA (FR) taken back off quick pace, raced wide entering lane, moved up gaining close contention a furlong out but failed to sustain needed kick for late impact. GRIZZEL (IRE) was rated in range running through backstretch, sent driving four wide entering lane, continued with response racing three deep past eighth pole then flattened out. TEAM OF TEAMS raced in tracking position just behind quick running LULL through the backstretch, inched way up close near quarter pole but was no match when rival kicked clear at head of lane, kept along then weakened between a furlong out. GLORY TO KITTEN raced near then in the back and never loomed serious threat. CONQUEST HARDCANDY stalked the quick running pacesetter through early stages, hustled up in far turn then had nothing left in reserve in lane.
