DA BIG HOSS reserved along the inside, saved ground on the second turn when patiently handled, angled out with a quarter mile to go, reeled in the leader in midstretch and drew clear. POWER PED behind the leaders along the inside, challenged once in the stretch, gained a short lead, responded when engaged by the winner but could not stay with that one late. ROMAN APPROVAL set the pace along the inside, stayed on well to the final furlong and weakened. ST. ALBANS BOY within striking distance four wide, lacked a late bid. TOBIAS forwardly placed from the start, raced four wide on the second turn and had nothing left late. HYPER unhurried along the inside, lacked a late bid. CAPTAIN DIXIE Within reach early three wide, saved ground on the second turn and had no late bid. BAILOUTOBOBBY was no factor. MYGALSAL outrun for a mile, could not menace. AZ RIDGE closest to the pace, stayed on to the final quarter and gave way. DRAMEDY reserved early, made a mild move after a half but gave way and was eased up late. O'PRADO OLE forwardly placed from the outset, was three wide on the second turn and faded.
