AUNT NELLIE was ridden along at the back, raced in the two path on the turn, swung six wide into the stretch, was briefly off heels at the quarter-pole then shifted further out, rallied on the outside under a right-handed whip, closed well into the final furlong, drifted in while gaining at the sixteenth-pole, took over shortly thereafter and drew clear while held together to the wire. **CONQUEST TIZ ONE** chased the pace, lugged out while two then three wide on the turn, came four wide into the stretch, jostled with **KOHEN'S TOP CAT** at that point, chased into the final furlong, drifted out severely in the final sixteenth and just got up for the place. **SMITTY'S COUGAR** was away alertly, quickly crossed over then sped clear, dictated terms while inside on the turn, was asked once straightened for the drive, came under a left-handed whip in upper stretch, switched to a right-handed whip at the furlong marker, led into the final sixteenth, was collared by the winner soon after then weakened and was denied the place. **OH DEAR LORD** hit the outside of the gate lightly at the start, was ridden along while well back on the outside, went three wide on the turn, came five wide into the stretch and failed to threaten while passing several opponents. **MS RUNCAT** was taken up early, raced off the pace while ridden along, saved ground on the turn, came out at the quarter-pole and failed to rally. **M. B.'S VOW** was urged along while off the pace, went three wide on the turn, checked when **CONQUEST TIZ ONE** came out at the five-sixteenths, moved to the four path and also failed to threaten. **MIS ISLA** was ridden along towards the front, chased three then two wide on the turn, came under the whip in upper stretch and capitulated. **KOHEN'S TOP CAT** chased the pace on the outside, went four wide on the turn, jostled with **CONQUEST E ZONE** while five wide into the stretch and had nothing left. **HAND ME THE CASH** was away alertly, chased the pace, raced in the two path for most of the turn, dropped to the rail late on the bend and tired. Following the race, the rider of **MS RUNCAT** claimed foul against **SMITTY'S COUGAR** for alleged interference early in the race. After the stewards' review, no change was made to the order of finish.
