Gray or Roan Colt, (Apr), by Tapit - Fast Cookie by Deputy Minister. Trainer Kiaran P. McLaughlin. Bred by Darley (KY).

FROSTED scraped the left of the gate with its hind quarters, took up position in the two path, sat poised on the turn within striking distance of the front runners, slithered out into path four leaving the five-sixteenths pole, was still in hand bidding for command as the field headed home, settled into upper stretch before asked for some run, scampered away to emerge at the furlong marker, in total control, drew out even more, asked but not fully so before getting geared down in the final seventy yards. ANCHOR DOWN broke alertly despite bobbing as the field was sent off and running, remained forwardly placed, departed the backstretch entrenched in the three path, forced the issue as the widest of a trio from the top of the turn to the quarter pole, was under a full drive heading home, failed to keep up with the winner during the stretch run, had enough though to secure second. UPSTART off the inside throughout, was in the two path and between rivals entering the turn, remained so for a good portion for the next quarter, got put a drive entering the turn, gradually ranged up towards the front runners, split them with approximately a furlong to go and was along for show. MARKING away well, was sent over into the two path proceeding down the backstretch, vied for command from the half mile pole to upper stretch before tiring. AMI'S FLATTER travelled four wide on the turn, drifted from upper to midlane to be eight wide, mustered up a response afterwards to mainly improve position. NOBLE BIRD lightly hand urged after leaving the gate, cleared to the front, cut over to the rail, was forced to fend off a pair of opponents from the crown of the turn to its end, gave in to heavy pressure coming to the quarter pole and faltered. BLOFELD rode the rail, was briskly hand urged cutting the corner into the lane, made no impact after abandoning the inside route at the eighth pole. STANFORD had the pilot grab hold after swerving at the start, sat reserved in the three path for nearly three-quarters, failed to fire for the drive home. TAMARKUZ took up the chase three to four wide on the turn, swung five wide into upper stretch, had little left and gave way. CALCULATOR lost his footing at the start, left the midway point on the turn three wide, never got involved.
