1 1/4 MILE. (1:42) STAKES. Purse \$200,000 Rachel Alexandra S. (Grade II) FOR FILLIES THREE YEARS OLD. By subscription of \$200 by Saturday, February 2. \$1,000 to enter, \$1,000 additional to start. Supplemental nominations of \$4,000 will be accepted at time of entry which shall include all fees. \$200,000 Guaranteed of which 60% to the winner, 20% to second, 10% to third, 4% to fourth, 2% to fifth and 1% to finishers sixth through ninth. Weight: 122 lbs. Starters to be named through the entry box by the usual time of closing. The Rachel Alexandra Stakes will be limited to fourteen (14) starters. Preference will be given in the following manner: graded or group winners in order (I, II, III), then highest lifetime earnings. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee or supplementary nomination fee if applicable. A trophy will be presented to the winning owner. Certain finishing positions in this race will earn points to qualify for the 2019 Kentucky Oaks, pursuant to the official rules for the Road to the Kentucky Oaks published by Churchill Downs. Points will be earned in the following manner: 50 to the winner, 20 to second, 10 to third and 5 to fourth. Nominations closed on Saturday, February 2, 2019 with 21 nominees. (Cloudy 71)

Dark Bay or Brown Filly, (Jan), by Alternation - Havisham by Bernardini. Trainer Thomas M. Amoss. Bred by Tri Eques Bloodstock, LLC (KY).

SERENGETI EMPRESS was hustled to the lead, set the pace while inside to the two path, responded well when asked after turning into the stretch, drew off under a drive into the final sixteenth then was eased up late while much the best. LIORA went three to four wide on the first turn, tracked the pace on the outside, raced three to four wide while ridden along on the far turn, was carried out a touch near the five-sixteenths and safely secured the place while no match for the winner. ERES TU went five wide early on the first turn then dropped to the two path, settled at the rear, was urged along while two then three wide on the far turn, shifted four wide approaching the quarter-pole, dropped in near the three-sixteenths and got up for the show. STREET BAND was taken back while crowded between horses early, raced inside under a tight hold on the first turn then was rated off the pace, started the far turn on the inside then moved to the two path, chased into upper stretch and weakened. NEEDS SUPERVISION went four to five wide on the first turn, settled on the outside, was urged along while four wide early on the far turn, moved to six wide while carried out some around the five-sixteenths and failed to rally. OXY LADY went three to four wide on the first turn, settled towards the rear, was roused while three then two wide on the far turn and failed to threaten. MOLTO BELLA went two to three wide on the first turn, tracked the pace down the backstretch, chased two to three wide on the far turn, dropped back late on that bend and retreated. POSITIVE SPIRIT was restless in the gate, went two to three wide on the first turn, settled off the pace, was roused while moving from the two path to the rail on the far turn and failed to respond then faltered. Following the race, the rider of NEEDS SUPERVISION claimed foul against STREET BAND for alleged interference near the five-sixteenths. After the stewards' review, no change was made to the order of finish.
