For horses not originally nominated, a supplemental payment of \$2,000 along with the entry and starting fees may be made at any time prior to the publication of weights. The purse to be divided 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among the remaining finishers. Dark Bay or Brown Filly, (Mar), by Tale of the Cat - Exotic Bloom by Montbrook. Trainer Todd A. Pletcher. Bred by Harvey Clarke & Brookdale Farm LLC (KY).

STOPCHARGINGMARIA was asked from the start, pressured UNTAPABLE from the outside while in the two path on the first turn, backed off that rival near the seven-eighths pole, stalked outside down the backstretch, went three wide on the far turn, was put to a drive nearing the quarter-pole, entered the stretch side by side with UNTAPABLE, dueled with that rival into the final sixteenth, was given three cracks of a right-handed whip at that point and proved best under good handling. UNTAPABLE went to the front, was pressured through the opening quarter-mile while along the rail, set the pace while off the inside on the backstretch, vied near the rail on the far turn, was put to a drive approaching the quarter-pole, dueled with the winner under a right-handed whip in upper stretch, switched to a left-handed whip just inside the furlong marker, fought into the final sixteenth then was outfinished while clear for the place. TIZ WINDY was reserved while three wide on the first turn, moved up near the five-eighths pole, settled while still on the outside, raced four wide on the far turn, was asked at the three-eighths pole, came under a right-handed whip at the five-sixteenths, switched to a left-handed whip in upper stretch and lacked the needed kick while clearly best of the rest. HOUSE RULES broke a bit slow, went three wide on the first turn, settled on the outside, was asked while three wide on the far turn, came under a strong hand ride at the five-sixteenths and failed to respond. IMPOSING GRACE settled on the inside while near the back, was urged along while along the rail on the far turn and also failed to respond. PRIVET HEDGE broke a half-step slow, was reserved while in the two path on the first turn, moved up near the five-eighths pole, went around the far turn in the two path while in striking range, was asked at the five-sixteenths and came up empty.
