Horses starting in the Riley Allison or Mine That Bird Derby Starters to pay \$2500. Horses Starting in both the Riley Allison Derby and the Mine That Bird Derby Guaranteed. Starters to pay \$1,250. Weights; Colts-Geldings 122 lbs. Fillies 117 lbs. Starters to be named through the entry box at the usual time of closing. First preference; lifetime earnings in graded stakes, second preference; highest lifetime earnings. Horses excluded at time of entry to receive full refund of all payments. RUNAWAY GHOST rated outside just off the early leaders five to six wide, advanced four wide on the far turn taking over the lead by the quarter pole, drew clear in upper stretch when asked near the furlong marker, held sway with mild urging. DREAM BABY DREAM settled outside last but one early, took closer order into the far turn, moved five then six wide on that bend, was no match for the winner but clearly second best. PEACE was lightly bumped at the break, tracked mid-pack, lost ground while between rivals into the far turn, shifted six wide leaving that bend, and on to get up for show. SEVEN TRUMPETS forced three wide into the first turn, settled off the leaders before advancing four to five wide and between foes on the second turn, moved into third in mid-stretch but lost that position late. DARK VADER steadied when in tight at the break, tracked in behind the leaders from the second flight, came out a bit leaving the far turn, was four wide at the head of the stretch but forced to alter course for room, gained up the rail but needed more. CHOO CHOO shifted in entering the far turn content to track in behind, raced mostly two to three wide till the far turn, came out a path and lacked the needed late kick. SHANE ZAIN stalked the leaders three to four wide, made a mild bid at the five-sixteenths, flattened out in the lane. ALL OUT BLITZ set the early tempo facing pressure, was getting out a bit leaving the first turn, continued to vie with rivals till late on the far turn, gave way in the stretch. PRINCE LUCKY was fractious in the gate, settled at the rear, swung seven wide and improved position. NEW YORK CENTRAL pressed the pace, bid between foes on the far turn, gave way at the head of the stretch. HOLLYWOOD STAR broke outwardly bumping a rival lightly, had no response. FORTIFIED EFFORT was urged at the break, shifted in and moved up on the rail through the first turn to attend the pace inside, tired. DUE TO TIMER MALFUNCTION, FIRST QUARTER-MILE FRACTIONAL SPLIT UNAVAILABLE.
