NEW MONEY HONEY away in good order, was in hand gliding over to the rail coming to the top of the clubhouse turn with the advantage, set the splits being rated along, with DREAMING in attendance out in the two path, close by but unhitched for the majority of the journey to the quarter pole, shifted into the two path leading the competition into the stretch, was in the general area of the three-sixteenths pole before getting asked for a response, gave it, digging in with good determination to fend off FIFTY FIVE in the final furlong. FIFTY FIVE settled into the pocket shortly after the break, was patiently ridden keeping watch on the front runners, continued along under the same scenerio to the end of the second bend, cut the corner with enough clearance to launch a rally along the rail corridor and was given her cue, made no headway during the ensuing furlong, tipped out late but to no avail, ultimately having to settle for the place. DREAM DANCING stalked the winner from the two path for over three-quarters, stepped into the stretch and was outfinished. COASTED fidgeting about in the starting gate, wound up getting away approximately a length slower than any other, got guided over into the twp path, continued to take up the chase from there on turn one and down the backstretch too, tipped out path three commencing to scurry into contention, made contact several times with an entrapped ENCHANTING KITTEN from the three-eighths pole to the five-sixteenths pole, but stubbornly held her position, spun four wide into the stretch and soon flattened out. ENCHANTING KITTEN sat well reserved in the two path during the early going, got put into a blindswitch coming to the three-eights pole as COASTED was unleashing her run into contention, shifted and made contact with that foe at least four times, the first behind the most solid of all, failed to bull her way to the outside though, got spotted three wide at the head of the stretch and came up empty. CORPORATE QUEEN saved ground to upper stretch while nearly trailing throughout.
